ADMINISTRATIVE ORDER NO. 1-44.0

**IN RE: CREATION OF SUMMARY REPORTING SYSTEM OVERSIGHT  
COMMITTEE AND SUBCOMMITTEES**

WHEREAS, pursuant to Section 25, 075, Florida States, the Supreme Court of Florida developed a uniform case reporting system; and

WHEREAS, the Summary Reporting System (SRS), as it is commonly known, provides the Office of the State Courts Administrator (OSCA) with data which assist the Supreme Court in its management oversight role; and

WHEREAS, it is incumbent on each judicial circuit to ensure that the data being sent to OSCA and the Supreme Court accurately reflects the activity taking place within the circuit; it is hereby

ORDERED as follows:

1. The Tenth Circuit Summary Reporting System Oversight Committee is hereby authorized and created. It shall be made up of the following subcommittees: the Hardee County SRS Oversight Subcommittee, the Highlands County SRS Oversight Subcommittee, and the Polk County SRS Oversight Subcommittee, all of which are also hereby authorized and created by this Order.
2. The Hardee County SRS Oversight Subcommittee shall consist of the following members: the Administrative Circuit Judge, who shall also serve as chairperson of the committee, the Hardee County Judge, and the Clerk of the Court for Hardee County or his designee. At this time that is: Judge Marcus J. Ezelle, Judge Jeff J. McKibben and B. Hugh Bradley.

3. The Highlands County SRS Oversight Subcommittee shall consist of the following members: the Administrative Circuit Judge, who shall also serve as chairperson of the committee, the second full-time assigned Circuit Judge in Highlands County, the Highlands County Judge, and the Clerk of the Court for Highlands County or his designee. At this time that is: Judge Olin W. Shinholser, Judge Peter Estrada, Judge Anthony Ritenour and L. E. "Luke" Brooker.
4. The Polk County SRS Oversight Subcommittee shall consist of those persons named on the Chief Judge's Oversight Committee Memorandum which is issued each fall. At this time that is, in part: Judge Ellen S. Masters (Chairperson), Judge Harvey A. Kornstein, Judge Randall G. McDonald, Judge Keith Spoto, and Richard M. Weiss.
5. These committees shall meet at their discretion and their agenda shall be self-determined, so long as the goal set forth above is met.
