**ADMINISTRATIVE ORDER 1-1.47**

**ASSIGNMENT OF JUDGES  
JULY 6, 2015 THROUGH JANUARY 3, 2016**

WHEREAS, in accordance with the provisions of the Tenth Judicial Circuit Court's Local Rule One, which provides for the assignment of judges to sections and divisions of the Court; it is hereby **ORDERED AND ADJUDGED** that:

1. Administrative Order No. 1-1.46 is modified as outlined herein to provide for the assignment of judges to sections and divisions of the Court for the period beginning July 6, 2015, and ending January 3, 2016;
2. Effective July 6, 2015, the Polk, Highlands, and Hardee County Clerks of Courts shall assign cases to the sections and divisions of the court in accordance with the ratio shown in Exhibit A (attached and incorporated herein), which lists the assignments of judges to sections and apportionment of new caseload assignments.
3. The judges are assigned additional duties, as outlined in Exhibits B, C, D, E, and F (all attached and incorporated herein), in order to provide adequate judicial manpower for various divisions of the Court.
4. When a visiting judge presides over matters in a section due to the assigned judge's unavailability, immediately upon becoming available, the assigned judge shall notify the visiting judge and the Court Administrator of their availability and shall take the section assignments.
5. When two or more cases are consolidated, any judge to whom one of the cases has been assigned shall enter an Order of Consolidation and provide that all cases are assigned to the section having the lower numbered case file.
6. This Order is effective immediately for planning and implementation as indicated herein and shall **SUPERSEDE** Administrative Order No. 1-1.46 on July 6, 2015.

Isolated single day holiday duty shall begin at 5:00 p.m. on the preceding day and conclude at 8:30 a.m. on the day following the holiday.
