**SPECIAL ORDER**

**ADDITIONAL ASSIGNMENT OF CIRCUIT AND COUNTY JUDGES  
TO THE OTHER COURTS OF THE TENTH JUDICIAL CIRCUIT**

**WHEREAS**, it is necessary for the dispatch of business in the Circuit and County Courts in the Tenth Judicial Circuit for the following assignments to be made.

**NOW, THEREFORE**, I, Wm. Bruce Smith, under the authority vested in me as Chief Judge of the Tenth Judicial Circuit of Florida, in accordance with Rule 2.050(b)(4), Florida Rules of Judicial Administration, do hereby assign and designate the following judges as temporary judges of the Courts as herein set forth, and on the dates as indicated below, unless otherwise amended.
