WHEREAS, Administrative Order No. 1-1.50 provides for the assignments of judges from January 3, 2017, through June 30, 2017; and


WHEREAS, Exhibit A to Administrative Order No. 1-1.50 provides for the assignments of judges to sections and the apportionment of caseload assignments; and
