SPECIAL ORDER

**IN RE: REASSIGNMENT OF NON-COMMERCIAL REAL
PROPERTY/MORTGAGE FORECLOSURE CASES TO SECTION 16**

WHEREAS, to promote judicial economy, maximize judicial resources and provide for the prompt and efficient administration of justice in this circuit, the Court has determined that all non-disposed and reopened non-commercial real property/mortgage foreclosure cases and a limited number of closed non-commercial real property/mortgage foreclosure cases from Sections 04, 07, 08, 11, and 15 should be reassigned to Section 16; It is, therefore,

ORDERED AND ADJUDGED that:

1. The Polk County Clerk of Courts (hereinafter “the Clerk”) is hereby **DIRECTED TO REASSIGN** to Section 16:
 - A. All non-commercial real property/mortgage foreclosure cases filed prior to July 1, 2013, and all reopened cases originally filed prior to July 1, 2013, less and except those cases listed in Attachment A (which are cases that are currently set for a hearing), from Sections 04, 07, 08, 11, and 15. All cases filed on or after July 1, 2013, will remain in their current divisions; and
 - B. All closed non-commercial real property/mortgage foreclosure cases filed from January 1, 2011, up to and including June 30, 2013.
2. This Order shall be effective at 12:01am on January 18, 2014.
