**SPECIAL ORDER**

**CONSOLIDATION OF JUVENILE DEPENDENCY SECTION J5 INTO SECTION J4  
AND  
REASSIGNMENT OF SECTION J4 CASES TO SECTION J1**

**WHEREAS**, it is necessary that juvenile dependency sections J5 and J4 be consolidated in order to promote judicial economy, maximize judicial resources, and provide for prompt and efficient administration of justice in this circuit, and

**WHEREAS**, the judges of the juvenile dependency division, in conjunction with the Clerk of the Court for Polk County, have formulated a plan whereby cases will be reassigned,

It is **ORDERED AND DIRECTED** that:

1. The Polk County Clerk of Courts is hereby directed to reassign all cases currently assigned and designated as Section J5 cases to Section J4.
2. Effective November 30, 2008, the Polk County Clerk of Courts is hereby directed to cease assigning cases to Section J5.
3. Effective November 30, 2008, the Polk County Clerk of Courts is hereby directed to reassign the following cases currently assigned and designated as Section J4 cases to Section J1:
