Intensive Outpatient Program/Outpatient Program – consisting of the following services:

1. Individual counseling one hour a week (one session per week).
2. Group therapy sessions 3 times a week each group session lasting 3 hours in duration. Totaling 9 hours per week
3. Counseling with families as needed – contact with families once weekly.
4. Substance abuse education, such as strategies for avoiding substance abuse or relapse, health problems relate to substance abuse, motivational enhancement and strategies for achieving a substance-free life-style.
5. Life skills training such as anger management, communication skills, employment skills, problem solving, relapse prevention, recovery training, decision-making, relationship skills, and symptom management.
6. Training and advising in health and medical issues.
7. Employment or educational support services to assist clients in becoming financially independent.
8. Mental health services for the purpose of:
 - a. Managing clients with disorders who are stabilized.
 - b. Evaluating clients' needs for in-depth mental health assessment.
 - c. Training clients to manage symptoms.
 - d. Timely referral to an appropriate provider for mental health crisis or the emergency of a primary mental health disorder when the provider is staffed to address primary mental health problems.
