WHEREAS, it has become necessary to fill a vacancy in one of the positions of Official Court Reporter for the Tenth Judicial Circuit of Florida, and

WHEREAS, a majority of the circuit judges, in Conference, on May 17, 1990, approved the appointment for that vacancy; therefore it is,

- 2. That, Official Court Reporter Sharon McClellan shall continue her assignment to report all circuit in-court civil and criminal proceedings in Hardee and Highlands Counties. She will report probate, mental health and juvenile proceedings in these counties as directed by the presiding judge.
- 3. That assignments to judicial sections shall be in keeping with assignments in Administrative Order No. 1.36 and subsequent revisions of that assignment order.

- 4. That recording of proceedings in the Juvenile Division of the Circuit Court will normally be accomplished by electronic means. The presiding judge of the Juvenile Court may direct the assignment of an Official Court Reporter to report incourt proceedings as necessary.
- 5. That recording of proceedings in the County Court will normally be accomplished by electronic means. The presiding judge of the county may direct the assignment of an Official Court Reporter for county in-court proceedings. Such assignment will be made by the Court Administrator's office upon receipt of the order of the presiding judge.
- 6. That assignments include all in-court Circuit Court civil and criminal proceedings. Counsel in civil cases must arrange requested in-court reporting with the Official Court Reporter assigned to the presiding judge.
- 7. That this order cancels and supersedes Administrative Order No. 46.2 dated February 1, 1985.
- 8. This order is effective nunc pro tunc to June 18, 1990.
