WHAT: The Toby Center provides supervised visitation, monitored child exchange and therapeutic visitation in the community. Staff work with parents in advance to determine comfortable and convenient locations which offer children and parents safety, neutrality and enjoyment to accommodate visitation and child exchange. When appropriate, parents and children will enjoy our locations, including libraries, museums, university campuses and recreation centers. Toby Center monitors are professional, trained, with many who are parents, and come from different fields as education or psychology. They are all respectful, compassionate and vigilant. Many are grandparents or divorced parents themselves. All monitors are trained to observe, to document, to guide. Therapeutic visitation is facilitated by certified and licensed monitors.

WHO: Any parent, guardian or other family member with or without court orders seeking a neutral, family friendly venue for child transfer and supervised child access/visitation.

WHEN: All service times are flexible and conveniently after work and school, and on weekends to accommodate all parties. Additional times may be requested with field monitors assigned who can accommodate family needs.

HOW: Easy Online Registration and Sliding Scale Fees! Standard Visitation: \$50 to \$75 per hour. Therapeutic Visitation: \$90-120 per hour. Initial Intake fee is required, \$95 per parent or guardian. Monitored Child Exchange fee is \$49 per one way exchange per day or evening. The client family will be responsible for any additional fee as admission fees for i.e., park, museum, theater and security if requested.
