

### ***CRITERIA FOR COMPLETION***

**The client will have completed the  
Juvenile Drug Court Program  
when he/she has:**

#### **Court Ordered Diversion Program**

- ◆ Completed his/her goals and objectives of the treatment plan.
- ◆ Remained drug/alcohol free for at least 60 consecutive days.
- ◆ Paid all fines and fees (if applicable).
- ◆ Completed court sanctions.
- ◆ Continues to pursue academic or vocational goals.

#### **Intervention and Outpatient Treatment Program**

- ◆ All the above except paying of fines and completing court sanctions.

#### **Results**

- ◆ For Court-Ordered clients, the charges will be dismissed from the client's permanent record.
- ◆ Improved family communication.
- ◆ A chance to start a drug and alcohol free life.

**Court Ordered Diversion Program**

Is a minimum of 4 months, multi-phase program that brings together the combined energy of the court system along with parental and judicial authority in order to break the early addiction cycle of an adolescent client. It addresses the disease of substance abuse, encompassing the environmental, social, physical, and emotional aspects of the client.

**Outpatient Treatment Program**

Is a minimum of 4 months, multi-phase program with the same purpose except the client is voluntary. The two placements listed in the next column are also used in addressing the same issues. The difference is that positive drug screens are not reported to the courts. However, progress reports will be sent to the referral source. Example: If the school board is involved, a report is sent to them. Parent participation is required.

**Intervention** Is psycho-education focusing on decision-making, life skills, self-esteem and family communication. The client and parent will be expected to participate in separate sessions on substance abuse education, relapse education, relapse prevention and relationships. There will be individual and family sessions to promote insight and positive behavioral change. Frequent random drug screens and weekly education classes, HIV/AIDS education class and Support Group meetings.

**Substance Abuse and Chemical Dependency Treatment** focuses on abstinence through individual and group counseling, the recovery model, decision-making skills, peer and family relationships. Clients process the cause and effects of substance abuse in their lives. This placement includes individual and group therapy, random drug screens, Support Group meetings and HIV/AIDS education class. Such topics as honesty, positive thinking, trust, acceptance, self-esteem, forgiveness and consequences of using drugs/alcohol are discussed in treatment. A Treatment Plan is individualized to client needs.

***What are the Requirements?***

**A written commitment from the client and parent(s) or guardian including:**

- ◆ 4 month (minimum) program participation
- ◆ length of program dependent on client's progression in treatment
- ◆ compliance with all court sanctions
- ◆ on-going communications between parent/guardian and the Drug Court program counselor.
- ◆ continued participation and attendance in school or obtaining G.E.D.

For an appointment, call (863) 534-4612. An appointment is given for a client and parent to meet with the juvenile counselor. If placement is needed, a treatment plan is developed with the client. An in-house laboratory provides quick turn-around on drug screen results.

***Actual time in the program is dependent upon the individual's participation, compliance and progress in the program.***
